do hereby acknowledge and agree to the following:	

- 2. I shall conform to the principles of animal welfare and wildlife conservation; objectives / mission as stated in the Trust Deed of the WRRC and terms of the Memorandum of Understanding dated 15<sup>th</sup> march 2000 between the Karnataka Forest Department and the WRRC. I also hereby agree to abide by the rules, regulations, policies, guidelines, SOPs (Standard Operating Procedures), resolutions and directions issued by WRRC. I am fully aware that the animals and birds I rescue and deal with are protected by the Wildlife Protection Act (WLPA) 1972 and I shall not do any act/s that is /are in contravention of the WLPA, 1972 of WLPA or any other laws of the country and in the event I violate the same, I shall be solely responsible for the same.
- 3. I agree to abide by the directions issued by the WRRC Board in respect of work entrusted to me, hours of work and all matters relating to my activities as a volunteer of WRRC. I agree that the volunteer timings are between 9 am to 4 p.m. and I shall not stay at any of the WRRC campus / premises beyond the above timings except with the written permission of the WRRC Board which may be granted in cases of

emergency or unavoidable circumstances. Further, I shall enter in the Volunteers Register / Records details of my visits, work accomplished and all other particulars called for by the WRRC Board.

- 4. I shall abide by all the decisions/ directions of the Board or Committee / persons authorized by the Board in respect of admission, treatment, housing, release / rehabilitation, euthanasia, transportation, feeding, neonate care and any other matters related to project / activity of WRRC and shall not interfere in the manner of utilization of funds or voluntary contributions of WRRC or any of the decisions taken by the WRRC Board. Further, I shall abide by the decisions of WRRC pertaining to construction of aviaries, cages and other animal houses and any other infrastructure at any centre owned / managed by WRRC. In general, I shall abide by all decisions of the WRRC Board and shall not interfere with the management of BRC or any activities of WRRC or cause any disturbance to the functioning of WRRC's BRC project or any other project or activities related thereto.
- 5. I shall maintain and preserve confidentiality at all times and shall not divulge any information relating to BRC or the work of the WRRC to any individual/s or agencies except with the written consent of WRRC Board.
- 6. I understand that animals maybe unpredictable at times and accept the risks of working with animals which include, but not limited to bites, abrasions, broken bones, bruises, injuries, illness, and other physical and mental injury including the risk of catastrophic injury or death. I also understand that the centers run by WRRC are situated in wildlife habitats or adjacent to wildlife habitats and prone to risks of attacks from wild animals. I understand that I am required to provide my own health and accident insurance at my own costs. I understand and agree that WRRC is not responsible for any medical expense/s that I may incur due to any injury, exposure, or illness sustained from or while volunteering at any of the WRRC Centres or during the course of any work undertaken by me on behalf of WRRC. I also assure, defend and hold the WRRC harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever sustained by any animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities or violation of any wildlife or any other laws.

- 7. I shall abide by all the rules and regulations / guidelines pertaining to volunteers and visitors and shall not entertain visitors or any other persons at any of the centers run by WRRC.
- 8. I shall abide by the decisions of the Veterinarian in-charge of BRC, (or any other centre owned / managed by the WRRC) pertaining to health, veterinary care and treatment of wild animals.
- 9. I shall report to the WRRC Board Trustees or any authorised representative of the WRRC Board in respect of all matters relating to the work of any of the centers/projects of WRRC and I shall attend all volunteer meetings of WRRC and / or any other meeting as and when called for by the WRRC Board of Trustees.
- 10. I shall not remove any animal from any of the centers managed by WRRC or from the custody of WRRC or shelter or provide foster care or board any of WRRC's animals in my home or office or any other place except with the written consent of WRRC Board and subject to all conditions imposed by the WRRC Board.
- 11. I shall be respectful of the fragile nature of the WRRC Campus and shall remove all garbage especially plastic bags; leave wildlife undisturbed; leave flowers, grass, plants and similar treasures untouched and to all act/s necessary to minimize the adverse effects on the landscape and to take back only memories.
- 12. I shall use the facilities of the premises only for purposes of work related to wildlife and shall not use the premises for any illegal / immoral activities or any such activities. Further, I shall not smoke, consume alcohol or be under the influence of alcohol or mind-altering drugs while volunteering at any of the centers of WRRC or during rescue operation or any other work of WRRC and shall not create any kind of disturbances within the campus of BRC or any of the centers managed the WRRC or while representing WRRC in any Forum or in the course of any work assigned to me by WRRC.

13. I shall not engage in any videography, photography and so on of any other centers/ activities run by WRRC except with the written permission of WRRC Board and in such an event, the said videography, photography and so on shall belong to WRRC and be the property of WRRC.

14. I shall maintain good cordial relations with the Trustees, members, volunteers, staff, guests, visitors and associates of WRRC and shall not do any act/s that is detrimental to the interests of WRRC or against the objectives of WRRC.
